Qualcomm – Implications for Your Supply Chain and EU's Renewed Focus on the Tech Sector – Apple, Broadcom, FRAND and the IoT</b>  <b>Noah Brumfield</b> will be discussing antitrust rules for interactions with competitors and customers, studying the lessons from HP v. Quanta. We will learn to face the challenge when customers are also competitors, and the takeaways from FTC v. Qualcomm for your supply chain.  The European Union has a renewed focus on the technology sector. <b>James Killick</b> will also present the latest EU antitrust cases in this sector and its inquiry into the Internet of Things (IoT). <b>Wednesday</b> <b>9 September 2020</b> 5:30 p.m. – 7:00 p.m.	<b>Webinar 2   Global FDI Trends, Export Control and Trade Issues</b>  FDI screening has substantially increased across the globe over the past three to four years and, after the outbreak of COVID-19 and an impending economic recession, FDI restrictions are also used to combat opportunistic M&A from companies and jurisdictions with deep pockets. In this webinar, <b>Farhad Jalinous</b> and <b>Tilman Kuhn</b> will focus on how deal-making has been impacted by changes to Foreign Direct Investment (FDI) regimes, with a specific focus on the US (CFIUS) and Europe.  <b>Cristina Brayton-Lewis</b> , a partner focusing on export controls and sanctions, will discuss the aggressive expansion of US export controls over the past 12 months, particularly those related to technology, and how they affect Taiwanese exports.  Finally, <b>Christopher Corr</b> will discuss how the “new normal” has affected trade and its implications for Taiwan exporters. He will explain how moving around the tariff wall has gotten more difficult and more dangerous, and that Taiwan-invested companies using third-country parts should take note, taking into account recent USG proposals could make it worse.
